The vehicle shall be operated under these conditions:

- 1. Only the individual who signs the affixed Waiver and Release of Liability for the Use and Enjoyment of the City Owned Courtesy Car may operate said car.
- 2. The vehicle shall remain within a twenty-five (25) mile radius of 176.
- 3. The vehicle must be returned to I76 by the close of hours of operation (shown above). Upon return, any problems, issues, or damage shall be reported to airport staff.
- 4. Vehicle use shall be restricted to two (2) hours. If a driver/pilot needs to travel beyond twenty-five (25) miles, exceed two (2) hours, or use the car overnight; seek prior permission from airport staff.
- 5. The Driver/Pilot must supply a cellphone number or other contact number where he can be contacted.
- 6. The City of Peru and Peru Municipal Airport does not carry or provide auto insurance for the courtesy car. Insurance is the sole responsibility of the Driver/Pilot and is required by state law. Driver/pilot must provide proof of a valid auto insurance policy prior to use. Be prepared to provide Proof of Insurance to Law Enforcement while operating the courtesy car.
- 7. The Driver/Pilot must sign the affixed Waiver and Release of Liability for the Use and Enjoyment of the City Owned Courtesy Car. Signing said waiver and release is an acknowledgement of reading, understanding, and accepting all terms herein.
